### **1.0 Call Meeting to Order:**

The West Jackson County Utility District (WJCUD) convened the scheduled board meeting June 15, 2023, at the WJCUD general office building, 7200 McCann Road, Biloxi, MS. The meeting was called to order by Mr. Mike Montgomery, Chairman of the Board at 9:05 A.M., and it was determined that a quorum was present. ## 4.0 Community Input

Mr. H. L. Callender, resident of 6556 Balboa Circle, addressed the Board regarding his high usage water bill. Mr. Callender stated that the high usage of water continued for 21 days, but then the usage returned to normal without knowledge of the cause. Chairman of the Board will call Mr. Callender this afternoon to set up a time to meet with him. The Chairman of the Board suggested changing the meter out if no leaks are found at this meeting. Regarding the bill, the Board Attorney referred to our policy which states that the only way an adjustment can be made to a bill is if we find the meter to be deficient.

Mr. Marty McGrath, Biloxi Bay RV Resort, addressed the Board regarding expansion to the resort. Mr. McGrath stated that he has recently been awarded Gulf Coast Recovery Funding which will aid in the expansion of 64 additional sites. Mr. McGrath would like to pay the proper sewer and water tap fees for this expansion. The Board Attorney recommends a meeting with Mr. McGrath and the Director to discuss a memorandum of agreement for this new phase. The Director would like to meet next week.

Mr. Jason Fayard, resident of 9112 Daisy Vestry Road, addressed the Board regarding two of his duplex rental properties located within the District. At the last board meeting, Mr. Fayard requested two water meters at each duplex to monitor each unit's water usage. Mr. Fayard is also asked that the billing accounts be coded residential to allow the accounts to be put into the tenants' names.

Upon a motion by Mr. David and a second by Mrs. Strayham, the Board unanimously voted, based on a finding of fact that in 2006 the District erroneously permitted a single grinder to service two duplexes, that in order to resolve a doubtful and disputed claim made by Jason Fayard, the following action will be taken:

- 1. The District will provide and install a grinder system at 8200 Cimarron Ave., and waive inspection fees associated with same;
- 2. Mr. Fayard will be responsible for running electrical to the new grinder system;
- 3. Mr. Fayard will execute a hold harmless with respect to all the District activities in this regard;
- 4. Mr. Fayard will be responsible for any revisions to water services at his properties in accordance with the District's standard fee schedule; and
- 5. The District will convert the relevant accounts to residential.

Mr. Fayard expressed his agreement with this arrangement.
